These policies insure that planned gifts not only support the Library's programs now, but also grow over time to finance library activities into the future.

Additional gifts to the endowment fund allow the Library to continue to meet the growing and transforming needs of the community. They assure the intellectual and cultural freedom of our unique community. It allows us to provide the essential and vital services to everyone of all ages in our community.

### *Major types of Planned Gifts:*

**Current Gifts:** *Giving to the Library Endowment now, including gifts of cash, real estate and/or securities. These gifts can reduce your income tax as well as any potential capital gains on appreciated securities or real estate.*

**Bequests:** *Naming the Library in your will. These bequests will be deducted for estate tax purposes from the value of your estate.*

**Income Gifts:** *Securing fixed annual payments for life by making the gift of a Charitable Gift Annuity. You can take a charitable deduction for part of the value of your Charitable Gift Annuity when you file this year's income tax return. A sizable part of each annuity payment is also income tax-free.*
